AFSA's primary research goal is to fund projects designed to explain the physiology of fibromyalgia so better treatments can be tested. AFSA remains one of the only nonprofits funding biomedical studies on this condition and our awards program is essential for progress in the field.

The prior two projects funded by AFSA were delayed 18 months due to COVID, but both studies are nearly complete. Once the results for each are published around August of 2022, AFSA will resume accepting research proposals.
